## NOTICE OF ANNUAL GENERAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that the Annual General Meeting (the "Meeting") of the holders of Common shares ("Shareholders") of BARKSDALE RESOURCES CORP. (the "Company") will be held on Thursday, December 18, 2025, at 10:30 a.m. (Pacific Time) at 67 East 5<sup>th</sup> Avenue, Vancouver, BC V5T 1G7, for the following purposes:

- 1. to receive the audited financial statements of the Company for the year ended March 31, 2025, and the report of the auditor thereon;
- 2. to set the number of directors for the ensuing year at five (5);
- 3. to elect directors of the Company to hold office until the next annual meeting of Shareholders;
- 4. to appoint the auditor of the Company for the ensuing year and to authorize the directors to fix the remuneration to be paid to the auditor;
- 5. to consider and, if thought advisable, pass an ordinary resolution approving the Company's proposed omnibus share incentive plan, as more particularly described in the Company's management information circular dated November 5, 2025 (the "Circular"); and
- 6. to transact such other business as may properly come before the Meeting or any adjournment thereof.

This Notice of Meeting is accompanied by the Circular and either a form of proxy for registered Shareholders or a voting instruction form for beneficial Shareholders. Shareholders are requested to read the Circular and, in lieu of attending the Meeting in person, complete, date, sign and return the proxy or voting instruction form, as applicable, so that as large a representation as possible may be had at the Meeting.

As described in the Notice-and-Access notification mailed to Shareholders of the Company, the Company will deliver Meeting materials to Shareholders by posting the Meeting materials on <a href="https://www.barksdaleresources.com/investors#agm">https://www.barksdaleresources.com/investors#agm</a>. The use of this alternative means of delivery is more environmentally friendly as it will help reduce paper use, as well as the Company's printing and mailing costs. Shareholders will receive a Notice-and-Access notification, together with a proxy or voting instruction form, as applicable, which will contain information on how to obtain electronic and paper copies of the Meeting materials in advance of the Meeting.

Paper copies of the Meeting materials will be sent to you at no cost within three business days of your request, if such request is made before the Meeting. If you do request paper copies of the Meeting materials, please note that another proxy/voting instruction form will not be sent and you should retain your current one for voting purposes.
